Dear Sir,

- I, Abhijeet Bhagwat, a Chartered Accountant in practice, have been appointed by the Board of Directors of Force Motors Limited (the 'Company') as a scrutiniser for the purpose of scrutinising the postal ballot conducted through e-voting and ascertaining the requisite majority on e-voting carried out as per the provisions of Section 110 of the Companies Act, 2013, read with Rule 22 and Rule 20 of the Companies (Management and Administration) Rules, 2014, on the resolutions contained in the postal ballot notice dated 11th January 2021 (the 'Resolutions').
- 2. The notice dated 11th January 2021 seeking approval of members of the Company along with statement setting out material facts under Section 102(1) of the Companies Act, 2013; Regulation 36(3) of the SEBI (Listing Obligations and Directors Requirements), 2015; was sent by email to the Members who have registered their email addresses with the Company or depository / depository participants in view of the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 20/2020 dated May 5, 2020 and General Circular No. 22/2020 dated June 15, 2020 read with General Circular No. 39/2020 dated December 31, 2020 and SEBI Circular No. SEBI / HO / CFD / CMD1 / CIR / P / 2020 / 79 dated May 12, 2020, and the communication of assent / dissent of the Members took place through the e-voting system. The Company provided remote e-voting facility to the members to vote on the resolutions through the electronic voting platform provided by National Securities Depository Limited ('NSDL').
- 3. My responsibility as a Scrutiniser for the remote e-voting is restricted to make a Scrutiniser's report of the votes cast in "favour" or "against" the resolutions and "invalid" and "abstained" votes, based on the reports generated from the e-voting platform provided by NSDL.
- 4. Further to the above, I submit my report as under:
 - The Company has dispatched postal ballot notice to its members whose names appeared in the register of members / list of beneficial holders as on Friday, 15th February, 2019 (End of Day), through courier or through speed post to the members who have not registered their email IDs.
 - II. The Company has dispatched postal ballot notice and ballot form to the members whose names appeared in the register of members/list of beneficial holders as on Friday, 8th January 2021 (End of Day) through email at their registered email ID.
 - III. The remote e-voting period remained open from Tuesday, 12th January 2021 (9:00 Å.M.) to Wednesday, 10th February 2021 (5:00 P.M.).
 - IV. The members whose names appeared in the register of members as on the "cut-off" date i.e. Friday, 8th January 2021 (End of Day) were entitled to vote on the resolutions as set out in the Postal Ballot Notice of the Company.

- V. The remote e-voting facility was unblocked on Wednesday, 10th February 2021 immediately after the completion of voting hours.
- VI. All votes cast on NSDL e-voting platform upto 5.00 p.m. on Wednesday, 10th February 2021 were considered for my scrutiny.
- VII. The details containing, *inter alia*, votes cast in "favour "or "against" on the resolutions that were put to vote, and whose votes became invalid and number of votes abstained from voting, for remote e-voting report is generated from the e-voting website of NSDL - i.e. https://www.evoting.nsdl.com/. Thereafter, considering votes through remote e-voting, the result of the voting is given in this report.
