

## **Personal Data Protection Policy of Force Motors Limited (FML):**

The “Personal data” means any non-public personal information collected/received directly from you, during visits to our websites/ social media, including but not limited to full name, state, city, telephone number, e-mail address, vehicle/product type/model and reason for which you reach to us.

The Personal Data Policy of FML is as under:

### **1. Assurances:**

- a) FML endeavor to collect only reasonably necessary Personal data.
- b) FML process Personal data in accordance with applicable legal provisions.
- c) FML will not collect any personal data about you, unless you voluntarily choose to provide FML with it.
- d) FML do not collect any Special Categories of Personal Data (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data). Nor do FML collect any information about criminal convictions and offences.

- e) FML will ensure that it has, in relation to all Personal Data obtained and/or collected by it from you, shall be protected as per the provisions of the applicable Personal Data Protection laws, rules and regulations.
- f) FML will ensure to use the Personal Data only for the Purpose for which it is provided to it. FML will ensure only those employees/consultants/contractors of FML will have access to the Personal data, who need to know in the course of their employment/ services.
- g) FML will not to transfer or allow to be transferred, not to allow access to, the Personal Data, to any third party or used in prejudice to you or the person, to whom it belongs, without such person's consent.
- h) FML will take all reasonable measures to protect any Personal Data obtained and/or collected by it from you, against loss, unauthorised access, use, modification, disclosure or other misuse, and that only authorised personnel have access to that Personal Data;
- i) FML will immediately communicate in writing to you, about any unauthorised access, disclosure or other breach of these assurances and undertakings, and to assist you to take all steps to prevent further unauthorised access, disclosure.

## **2. Legal requirements and obligations:**

- a) FML will use the Personal data to protect its rights, users, systems, and services.
- b) FML may use Personal data to comply with legal obligations and respond to requests from government agencies, including law enforcement and other public authorities.
- c) FML may use Personal data to respond to requests from courts, law enforcement agencies, regulatory agencies, and other public and government authorities
- d) FML may be required to use and retain Personal data for legal and compliance reasons, such as the prevention, detection, or investigation of a crime; loss prevention; or fraud. FML may also use personal information to meet its internal and external audit requirements, information security purposes, and as we otherwise believe to be necessary or appropriate.

**3. Accuracy:**

- a) You are responsible for ensuring that the information you provide is accurate, complete and current.
- b) If the data we hold on you is out of date, incomplete or incorrect, you can inform us to correct, amend or delete any inaccuracies and your data will be updated.

**4. Disclaimer:**

- a) FML will not be responsible for disclosure of the Personal data, after ensuring reasonable security of it.
