End of remote e-voting	05:00 P.M. (IST) on Tuesday, 3 rd September, 2024

(D) Book Closure:

Pursuant to the provisions of Section 91 of the Companies Act, 2013, the Register of Members and Share Transfer Books of the Company will remain closed from **Thursday**, 29th **August**, 2024 to **Wednesday** 4th **September**, 2024 (Both days inclusive) for the purpose of AGM.
